

Application to revoke land as a private timber reserve

Requirements

Under section 14 of the Forest Practices Act 1985 the owner of a private timber reserve may make an application to revoke all or part of lands declared as a private timber reserve.

This application for the revocation of a private timber reserve must contain a description of the private timber reserve, or part of the private timber reserve that the applicant wishes to cease to be, or cease to form part, of a private timber reserve.

The applicant must also specify the reasons why the application is being made.

A separate revocation application is required for each different ownership, even though the land may be managed as one unit. For example, A. Smith, AB Smith, AB & CD Smith, A Smith & Co, or A Smith & Company Pty Ltd are all different titles and require separate applications to revoke the private timber reserve.

Please provide:

1. A FULL copy of the current title, in the name of the applicant, for each area of land covered by this application to revoke the private timber reserve. A FULL copy includes folio text, folio plan and where available Property Report with the area to be revoked clearly identified.
2. A 1:25,000 map with the area to be revoked clearly identified.
3. An electronic shape file with any part title applications - email to diana.hall@pft.tas.gov.au

Information on preparing maps and electronic data is available at www.pft.tas.gov.au under the private timber reserve tab i.e. *Application to revoke land as a private timber reserve - map and electronic data standards*.
